

#### Privacy Policy for MedVenture Networks BV.

At **MedVenture Networks BV**, we respect and protect your privacy. This Privacy Policy explains how we collect, use, store, and share your personal information when you register for or attend one of our congresses. We are committed to complying with international data protection laws, including GDPR, and to keeping your data secure.

### 1. Information We Collect

**For Educational and Promotional Purposes:** Photographs, videos, and audio recordings may be used to showcase our events and educational content in publications, on our website, or on social media.

**To Improve Future Events:** We analyze attendance data, feedback, and session participation to improve our programs and services.

**To Comply with Legal Obligations:** We may be required to share information to comply with local or international regulations, including safety and health regulations.

## 3. How We Share Your Information

**With Service Providers:** We work with trusted third-party service providers (e.g., event platforms, payment processors) who assist in running the congress. These providers are bound by strict data protection standards.

We select professional companies that adhere to strict data protection standards, and we have contractual agreements with them to ensure they handle your information responsibly. Our partners take privacy and data security very seriously, and they comply with applicable data protection laws to safeguard your personal information.

**With Speakers and Partners:** In some cases, we may share attendance lists (name, job title, organization) with speakers or session leaders to tailor content and engagement.

**Data Retention:** We retain personal data only for as long as necessary to fulfill the purposes described in this policy, comply with legal obligations, or as otherwise required by law.

**Security Measures:** We use industry-standard security protocols and practices to protect your information against unauthorized access, alteration, or disclosure.

### 5. Your Rights

175 to 150 days before the conference: 30% of the conference fee is refundable.

150 to 60 days before the conference: 50% of the conference fee is refundable.

Less than 60 days before the conference: No refund will be provided.
