A total of 40 successful practical cases will be visited by field review panels of 3-4 peers in each field review. Peers will be invited from project partners and from other selected successful cases (one person from partner/third party organisations, one advisor and one farmer). The field review cases will be selected to ensure a balance of topical and regional diversity, while review panels will as far as possible match the language and experience needed for each case. This will have the effect of embedding the learnings from best practice in the i2connect project team and in the wider community of successful practical cases in a participatory and interactive way.

The following output will be delivered and published on the i2Connect website: 40 individual reports (in local language and in English), which will document the findings of the field reviews of practical cases. Three series of reports will be produced during the project.

- D2.5: Second series of individual reports from the field reviews of practical cases (M40);
- D2.6: Third series of individual reports from the field reviews of practical cases (M54).

How are data being protected in WUR information systems

The protection of WUR information systems is based on measures as described within frameworks like BS 7799, ISO/IEC 17799 and ISO/IEC 27002:2017, and can be found in the <u>security policy</u> of Wageningen University and Research. These measures involve secure storage, encryption, monitoring, logging, authorization and authenticity techniques along further measures.

How are data being protected in Meteodocs

i2connect consortium members are using Meteodocs to internally share project documents: https://meteodocs.ilkc.lv/ Meteodocs is based on NextCloud platform (Release 15) which is a suite of client-server software for creating and using file hosting services. It is an open solution that provides a safe, secure, and compliant file synchronization and sharing solution on private server devices.

https://meteodocs.llkc.lv/ is located on LLKC server, and secures data in transit using TLS, the encryption protocol used by HTTPS. Access to document sharing platform is granted by platform administrator. In the document sharing platform https://meteodocs.llkc.lv/ operational information from WPs, deliverables in form of different documents, minutes of project meetings and events, pictures and presentations, grant agreement and legal documents and templates are stored and shared between partners.

Sharing data with other organizations and institutes

Data may be shared with all i2Connect 24 partners and third parties (Grant Agreement, N° 863039, European Commission, REA and the project website: https://i2connect-h2020.eu/project-partners/). The data within the i2Connect project will be shared to other participating research parties, but not with other third parties not connected to the project. These participating parties may be located outside the EEA.

Results from the research will be reported as aggregate data to the REA and will be used to influence the project development and the i2connect AS database. However, it is possible specific cases might be used without names and details, but due to the nature of the case might be relatable. At the end of the project period, data will be retained by the consortium members and will not be sold to a third party but could be shared for other project tasks and activities.

- 4. Data can be fully anonymized and reused for other researches, such as a follow up on this project. As data is anonymized the data is no longer considered as personal data and therefor the GDPR is no longer applicable
- 5. Understand that any personal data collected in the field review will be recorded and stored in accordance with the General Data Protection Regulation (GDPR). A copy of the i2connect data privacy policy should be made available by the organizers.
- 6. Are aware you have a limited right to revoke your personal data due to the nature of collecting and processing data in terms of research.
