Who is Global Legal Entity Identifier Foundation (GLEIF)?

- GLEIF is a not-for-profit Swiss foundation, founded by the Financial Stability Board (FSB).
- GLEIF is overseen by 65 regulators and 19 observers in the Regulatory Oversight Committee (ROC) from more than 50 countries.
- GLEIF Board has 19 independent directors.
- GLEIF makes available the LEI data free of charge.







MIC - LEI mapping

- The first MIC-LEI mapping file published in Nov. 2022
- About 900 mapping pairs and 780 unique LEIs covered as of April 2023
- Update monthly

BIC - LEI mapping

- The first BIC-LEI mapping file published in Jan. 2018
- Over 22,000 mapping pairs and 20,000 unique LEIs covered as of March 2023
- Update monthly

S&P Global Company ID – LEI mapping

- The mapping went live in Nov. 2022
- Mapping is published via LEI search and GLEIF API
- Over 98% of the LEI population is covered
- Update weekly
- Available on LEI Search and GLEIF API

ISIN - LEI mapping

- The first ISIN-LEI mapping file published in April 2019
- 28 NNAs opted in covering 63 jurisdictions
- Over 8 million mapping pairs and 90,000 unique LEIs covered as of April 2024
- Update daily


Mapping Partners

OpenCorporates ID - LEI mapping

- The first OpenCorporates ID-LEI mapping file published in April 2023
- Over 50% of the LEI population is covered (not all legal entities with LEIs are officially registered - e.g., funds)
- Update bi-weekly
- Available via LEI search and GLEIF API by the end of May



- Ultimate_Parents_PLC_GB.ipynb
 - Identify ultimate parents of British Private Limited Companies with jurisdiction Japan
- Umbrella_Funds.ipynb
 - Identify non-Mexican fund managers for Mexican funds and analyse umbrella funds and their sub funds in Mexico
- Feeder_Funds.ipynb
 - Investigate Dutch feeder funds and their master funds

- Exception Reasons:
 - No consolidating parent exists
 - Parent information is not public
 - Parent does not have an LEI

- Managing LOUs:

 - Validate reference data
 - Accredited by GLEIF

Example: LEI 213800DGPY4ZCTVJVQ23 has jurisdiction GB with authoritative source RA000585 (Companies House) is managed by London Stock Exchange, while its ultimate parent with LEI 5299009QN2NZ191KLS29 has jurisdiction JP with authoritative source RA000412 (Companies Registration) and is managed by Tokyo Stock Exchange.
