The authors of the proposal (contact person and co-proposers) will use only works that will be suitable to be used and built on them further and be compatible with the CC-BY-SA license.

The authors of the proposal (contact person, co-proposers) confirm that their proposal is their work and they are the copyright holders of it. In addition, the authors of the proposal (contact person, co-proposers) take responsibility that their proposal follows all the copyright rules, do not infringe anyone else's intellectual property rights and the appropriate measures have been taken in order for any document – input and output – to be shared openly under a Attribution-Share Alike 4.0 license and be compatible with this license.

The authors of the proposal (contact person, co-proposers) take responsibility that their proposal does not contain any confidential or otherwise sensitive information that should not be openly disclosed.

By submitting the proposal, the above is agreed and consented. If the authors of the proposal do not consent on this proposal to be part of a collective process of co-creation as described per the CAAD Futures 2023 Co-creation call and/or do not agree on the Attribution Share Alike 4.0 International license terms, they should not submit their proposal.
