REGISTRATION

Registration for the VISAR 2022 is to be made electronically by completing the respective registration form. Registrations without full name, complete email, postal address, and date of birth cannot be processed.

REGISTRATION OF THIRD PERSONS

Upon registration on behalf of third persons, the registering person warrants and guarantees to be entitled to execute such registrations according to these General Terms and Conditions in the name and on behalf of such third persons.

PAYMENT

Payment of the registration fee can be made by credit card (VISA or MasterCard) or PayPal. No other payment methods will be accepted. Upon receipt of the payment, a payment confirmation will be issued and sent via email.

CANCELLATION, POSTPONEMENT, RELOCATION

In the event of cancellation, postponement, relocation of VISAR 2022 due to events beyond the control of VISAR (e.g. cancellation of flights, strikes, natural disasters, epidemics, travel bans, official orders, closure of the event centre, etc.) MEDahead Gesellschaft für medizinische Information m.b.H./VISAR shall not be obliged to any refunds. In such event, the obligation of MEDahead Gesellschaft für medizinische Information m.b.H./VISAR shall be restricted to take reasonable efforts to relocate and/or to postpone the VISAR 2022 for not more than seven months from the original finish date. In the event of a relocation and/or postponement of the VISAR 2022, the contract partner of VISAR 2022 shall remain entitled to participate at the VISAR 2022 at the new date and/or the new venue under the same terms and conditions. In such event, MEDahead Gesellschaft für medizinische Information m.b.H./VISAR will not be liable for any damage or loss incurred by their contract partner. If, for any reason, it becomes impossible to hold the VISAR 2022 within the deadline of seven months, MEDahead Gesellschaft für medizinische Information m.b.H./VISAR will refund the amount paid to the contract partner.

REFUND

All requests regarding the refund have to be communicated in writing to the MEDahead Office (k.lula@medahead.at) within the following deadlines:

Until 17.04.2022

The refund of the paid registration fee is possible. A handling fee of 50,00€ will be charged.

Between 18.04.2022 – 08.05.2022

50% of the paid registration fee will be refunded.

After 09.05.2022

No refund of the registration fee is possible.

NAME CHANGES

Name changes will be treated like a cancellation of one registration and a new registration of another participant. New registration and payment are required.

CONGRESS MATERIAL

The congress material will be made available to the participant onsite at the registration desk.

BADGES AND SAFETY

Badges must be worn visibly on the meeting grounds at all times. The badge shows the following participants' details: first name, last name, city and country. Participants may at any time be requested to present adequate proof of identity in the form of a passport, driver's license, national or military identification or student ID.
