Registration Information and Privacy

What personal information will Impact Europe collect and store?

Who can view or handle my personal information?

Impact Europe employees who have been trained to handle personal information properly will have access to your personal information. Access to Impact Europe systems and database is restricted by means of password authentication.

Your personal information will also be 1) transmitted to supporters of our events (European Commission, in compliance with EaSI Privacy Statement) and 2) processed by our trusted partners (Aanmelder.nl) with whom we have covered comprehensive data protection and data processing agreements.
