

Terms and Conditions

ESSR Munich Sports Imaging Course

October 14-16, 2021 | Munich/DE

REGISTRATION

Registration for the above mentioned course is to be made electronically by completing the respective registration form. Registration forms without full name, complete email and postal address cannot be processed. To be eligible to register, participants must be at least 18 years old.

Registration fees depend on the date your payment is received at the ESSR bank account and will be considered as incomplete and adjusted accordingly if the payment is not received by the relevant deadline. The relevant ESSR registration deadlines are stated below.

REGISTRATION DEADLINES

Late Registration Fee	from July 1, 2021 onwards

ESSR/DGMSR Member Registration

Reduced course registrations are available to all active ESSR or DGMSR members.

Resident Registration

Registrations categorised as “Resident” are offered to residents (radiologists still in training) until the age of 36 (incl. the age of 36) as well as to students without any academic title until the age of 30 (incl. the age of 30).

Residents need a letter from their head of department, written on official hospital letter paper, confirming their resident status.

Students have to send, fax or email a copy of their valid student picture ID together with a copy of their passport within 5 working days after completed online registration. In case these documents are not received, a reduced registration will not be possible.

PAYMENT

Payment of registration fee is to be made by credit card (VISA or MasterCard). Payment by cheque or in any other way is not accepted.

Registration fees depend on the date the payment is received at the ESSR bank account and will be considered as incomplete and adjusted accordingly if the payment is not received by the relevant deadline.

BANK TRANSFER

For payment via bank transfer, your full name has to be indicated on transfer documents for identification purposes. The registered person is responsible for any bank charges incurred.

CANCELLATION by participant

In case of cancellation more than 30 days prior to the course, the registration fee will be refunded minus a cancellation fee of EUR 25,- (refund after the course)

A cancellation less than 30 days prior to the course will not result in a refund.

All cancellations have to be done in writing and sent to the ESSR Office (via email; office@essr.org).

CANCELLATION, POSTPONEMENT, RELOCATION by the organisers

In the event that it is judged advisable or necessary to have the MSIC 2021 event cancelled, postponed or transformed to a virtual event (e.g. natural disasters, epidemics, official orders etc.), MSIC 2021 shall not be obliged to any refunds.

NAME CHANGE

Name changes will be treated like the cancellation of one registration and the new registration of another participant. New registration and payment are required.

BADGES AND SAFETY (For f2f meetings)

The safety of all course delegates and participants is of utmost importance to the ESSR. Badges must be worn visibly on the course grounds at all times. The ESSR reserves the right for staff to check participants' identification upon admission to and/or inside the course venue. Participants may at any time be requested to present adequate proof of identity, in the form of a passport, driver's license, national or military identification or student ID. Documents for the proof of identity must include a photograph and signature.
