# General Terms and Conditions

# **EUSOBI Diagnostic and Interventional Breast Ultrasound Course September 16-17, 2021**

All time specifications within the EUSOBI registration process refer to CET (Central European Time). EUSOBI accepts no responsibility for errors or misprints.

### **REGISTRATION**

Registration for the EUSOBI Breast Ultrasound Course 2021 is to be made electronically by completing the respective registration form. Incomplete registration forms cannot be processed. It is the participant's own responsibility to provide all necessary details and documents and to ensure the completeness of their registration. The minimum age limit for registration is 18 years.

EUSOBI is using the secure online platform "aanmelder.nl" for online registration

After successful registration and successful payment, a confirmation email together with a payment confirmation document will be provided. Registration fees depend on the date your payment is received at the EUSOBI bank account and will be considered as incomplete and adjusted accordingly if the payment is not received by the relevant deadline. The relevant EUSOBI registration deadlines are announced on the EUSOBI website (<a href="www.eusobi.org/us-course">www.eusobi.org/us-course</a>).

## **MEMBER REGISTRATION**

Reduced course registrations are available to all active EUSOBI Members in 2021.

# RESIDENT REGISTRATION

Reduced resident registrations will be offered to residents (young radiologists in training). Residents have to send, fax or email a letter, written on official hospital letter paper and signed by the head of department, confirming their status as such within 5 working days after online registration. In case this confirmation is not received, the registration fee will be automatically adjusted to a regular fee. The age limit for a registration as a Resident is set at 35 years (incl. the age of 35).

# **REGISTRATION OF THIRD PERSONS**

Upon registration on behalf of third persons, the registering person warrants and guarantees to be entitled to execute such registrations according to these General Terms and Conditions in the name and on behalf of such third persons by proxy and to declare any and all approvals and consents required according to these General Terms and Conditions in the third person's name and behalf.

### **PAYMENT**

Payment of registration fee can be made by credit card (VISA or MasterCard). No other payment method will be accepted. Upon receipt of the payment, a payment confirmation will be issued and sent via email.

# **CANCELLATION POLICY FOR PARTICIPANTS**

In case of cancellation more than 30 days prior to the course, the registration fee will be refunded minus a cancellation handling fee of EUR 35,00 (refunds are processed after the course).

A cancellation less than 30 days prior to the course will not result in a refund.

# **CANCELLATION, POSTPONEMENT, RELOCATION**

In case of insufficient registrations (less than 40), EUSOBI reserves the right to cancel the course at the latest 6 weeks prior to its beginning. Please keep this in mind for your travel arrangements. Please be aware that EUSOBI does not cover or refund travel and hotel expenses in any case.

In the event that it is judged advisable or necessary to have the EUSOBI Breast Ultrasound Course 2021 cancelled, postponed, to have the location changed or to have the EUSOBI Breast Ultrasound Course 2021 closed early due to events beyond the control of its organisers (EUSOBI) (e.g. cancellation of flights, strikes, natural disasters, epidemics, travel bans, official orders, closure of the event centre, etc.) EUSOBI shall not be obliged to any refunds. In such event, the obligation of EUSOBI shall be restricted to take reasonable efforts to relocate and/or to postpone the EUSOBI Breast Ultrasound Course 2021 for not more than seven months from the original finish date. In the event of a relocation and/or postponement of the EUSOBI Breast Ultrasound Course 2021, the contract partner of EUSOBI shall remain entitled to participate at the EUSOBI Breast Ultrasound Course 2021 at the new date and/or the new site under the same terms and conditions. In such event, EUSOBI will not be liable for any damage or loss incurred by their contract partner. If, for any reason, it becomes impossible to hold the EUSOBI Breast Ultrasound Course 2021 within the deadline of seven months, EUSOBI will refund to the contract partner the sum paid, deducting the price for services still available (eg. online participation) and the expenses already incurred in preparations of the EUSOBI Breast Ultrasound Course 2021 on a pro rate base according to the percentage determined and disclosed by EUSOBI.

#### **NAME CHANGE**

Name changes will be treated like the cancellation of one registration and the new registration of another participant. New registration and payment are required.

# **BADGES AND SAFETY**

The safety of all course delegates and participants is of utmost importance to the EUSOBI. Security measures and precautions at the EUSOBI course venues have been tightened to ensure maximum security for all attendees. Badges must be worn visibly on the course grounds at all times. The EUSOBI reserves the right for staff to check participants' identification upon admission to and/or inside the course venue. Participants may at any time be requested to present adequate proof of identity, in the form of a passport, driver's license, national or military identification or student ID. Documents for the proof of identity must include a photograph and signature.
