

General Terms and Conditions ESSR 2021 – Annual Scientific Meeting June 10-12

The minimum age limit for registration is 18 years.

All time specifications within the registration process refer to CEST (Central European Summer Time). ESSR accepts no responsibility for errors or misprints.

REGISTRATION

Registration is to be made electronically by completing the respective registration form. Registrations without full name, complete email, postal address and date of birth cannot be processed. It is the participant's own responsibility to provide all necessary details and documents and to ensure the completeness of registration.

Registration fees depend on the date your payment is received at the ESSR bank account and will be considered as incomplete and adjusted accordingly if the payment is not received by the relevant deadline.

ESSR is using the secure online platform "aanmelder.nl" for online registration (https://www.aanmelder.nl/en). After successful registration and successful payment, a confirmation email together with a payment confirmation document will be provided. The login information for the virtual live event will be provided approximately 1-2 days before the online meeting starts. Login data are personalized and only available for the registrant him/herself. Forwarding and/or sharing the login details is not allowed and seen as a violation of registration, thus will result in the cancellation of the registration.

MEMBER REGISTRATION

Member registration is available free of charge for all active ESSR (active membership in 2021).

REGISTRATION OF THIRD PERSONS

Upon registration on behalf of third persons, the registering person warrants and guarantees to be entitled to execute such registration according to these Terms and Conditions in the name and on behalf of such third persons by proxy and to declare any and all approvals and consents required according to these Terms and Conditions in the third person's name and behalf.

PAYMENT

Payment of the registration fee can be made by credit card (VISA or MasterCard) only. No other payment method will be accepted. Upon receipt of the payment, a payment confirmation will be issued and sent via email.

CANCELLATION POLICY FOR PARTICIPANTS

A cancellation will not result in a refund of paid registration fee.

CANCELLATION, POSTPONEMENT, RELOCATION

In the event that it is judged advisable or necessary to have the ESSR 2021 Annual Scientific Meeting cancelled, postponed, to have the location changed or to have the ESSR 2021 Annual Scientific Meeting closed early due to events beyond the control of its organisers (ESSR) (e.g. cancellation of flights, strikes, natural disasters, epidemics, travel bans, official orders, closure of the event centre, etc.) ESSR shall not be obliged to any refunds. In such event, the obligation of ESSR shall be restricted to take reasonable efforts to relocate and/or to postpone the ESSR 2021 Annual Scientific Meeting for not more than seven months from the original finish date. In the event of a relocation and/or postponement of the ESSR 2021 Annual Scientific Meeting, the contract partner of ESSR shall remain entitled to participate at the ESSR 2021 Annual Scientific Meeting at the new date and/or the new site under the same terms and conditions. In such event, ESSR will not be liable for any damage or loss incurred by their contract partner.

If, for any reason, it becomes impossible to hold the ESSR 2021 Annual Scientific Meeting within the deadline of seven months, ESSR will refund to the contract partner the sum paid, deducting the price for services still available (eg. online participation) and the expenses already incurred in preparations of the ESSR 2021 Annual Scientific Meeting on a pro rate base according to the percentage determined and disclosed by ESSR.

NAME CHANGE

Name changes will be treated like the cancellation of one registration and the new registration of another participant. New registration and payment are required.

PERONAL DATA

Participants are entitled to revoke their consent to the specific data processing at any time by contacting the ESSR Office.

DOCUMENTS

A confirmation of attendance will be made available to the participants after the online course. Documents such as the confirmation of attendance will be saved and may be provided for a maximum of three years only. Confirmation of payments will be saved and may be provided for a maximum of seven years.

LIMITATION OF LIABILITY

There is neither any liability nor any obligation of ESSR in case of cancellation of the ESSR 2021 Annual Scientific Meeting for whatever reasons. Apart from damages caused by physical injury, the liability of ESSR for damages of any other kind shall be restricted to wilful intent or gross negligence. ESSR shall not be liable for any damages caused by force majeure.

PLACE OF PERFORMANCE/APPLICABLE LAW/PLACE OF JURISDICTION

The place of performance of any duties and obligations for ESSR and the participant sides shall be Vienna. Place of jurisdiction shall be 1010 Vienna, Austria. ESSR shall also be entitled to pursue any claim before the courts of law competent for the defendant's domicile or general residence. Any contractual relationship with the ESSR shall be subject to Austrian law.
